Coverage:

1. Warranty applies to B-TEK SCALES, LLC. Floor / Platform Scales shipped after June 1, 2021.
2. The warranty covers defects in materials and / or workmanship that lead to failure. The warranty provides for new or repaired Weighbridge / Components to replace defective parts. The warranty provides parts, labor and travel expenses within (90) days after shipment. After the (90) day period, labor and travel expenses are not covered.

4. B-TEK will pay the transportation charges, via standard ground delivery service, for warranty repair parts sent to an authorized distributor or end user location. Defective or failed parts must be returned, freight prepaid, to B-TEK for evaluation.
5. This warranty does not cover damage due to lightning, surge voltage, misuse, abuse, accident, neglect, alteration, modification, improper or unauthorized installation or repair, improper testing, superficial / cosmetic damage or deterioration, overloading or natural disaster.
6. Indicators, printers, scoreboards or other peripheral devices supplied with platform are not covered under this warranty. Please refer to the appropriate warranties for information on peripheral devices.
7. Warranty valid in North America only and is limited to the initial buyer / installation location and is not transferable.
